May commented, “Truxton has been fortunate to generate return on average shareholder’s equity (ROAE) higher than our recent and expected asset growth rate. Even with our regular dividends, the Corporation has seen capital ratios grow increasingly conservative, allowing us to pay this special dividend.”
