THE ROLE

The Credit Officer will work directly with the Bankers and the Chief Administrative & Risk Officer engaging in all areas of Truxton's credit and analytical function. This officer will work with the lenders to craft and approve credit proposals, underwrite and approve credits requests, and assist the Chief Administrative & Risk Officer in loan portfolio management, analysis, and reporting. We are looking for candidates with experience in bank loan analysis and with awareness of bank lending policies and procedures. Will require a person demonstrating strong analytical and underwriting skill sets coupled a developed strength in collaborative work on internal teams. The Credit Officer has significant exposure to senior management with opportunities for movement to leadership in banking and credit risk management.
